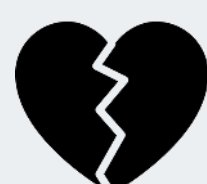

APOSTILLE STAMP & LEGALISATION

JuridConsult team can arrange an Apostille stamp within few hours. This type of legalisation applies to all countries' members of The Hague Convention on Apostille. If the document is issued in the contracting state of the Apostille Convention no further legalisation steps are required. In order to get an Apostille stamp, our team promises swift communication, careful realization, and fast delivery.

LEGALISATION OF DIPLOMA

The Netherlands is a very internationalised country with an enormous number of international students. That is why one of the JuridConsult includes the legalisation of diploma/educational documents. For all young professionals who obtained an educational diploma in The Netherlands and need to work abroad, JuridConsult offers its help in legalizing the document. All we need is the original document to be recognized by the Dutch Ministry of Education (DUO) system and validated by the educational institution. The rest legalisation steps will be performed by JuridConsult team.

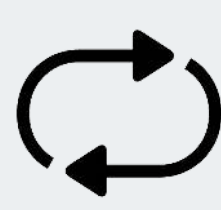

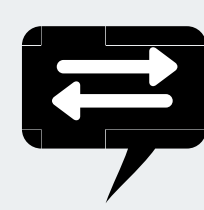
